

# **Tonbridge & Malling Borough Council Anti-Social Behaviour Enforcement Team**

## **Report for May to November 2025**



This report gives details of the work of the ASB Enforcement Team from 21 May to 16 November 2025. The ASB Enforcement Team were employed through Kingdom Services Group Ltd, and they provided two teams (comprising of four officers) who worked the following hours:

- Wednesday 12:00 hours until 20:00 hours
- Thursday 12:00 hours until 20:00 hours
- Friday 12:00 hours until 20:00 hours and 16:00 hours until 24:00 hours (midnight)
- Saturday 12:00 hours until 20:00 hours and 16:00 hours until 24:00 hours (midnight)
- Sunday 10:30am hours until 18:00 hours.

The ASB Officers wore a blue uniform (to distinguish them from the Kingdom Waste Enforcement Officers also employed by TMBC) and carried body worn cameras which could be used to record incidents. They provided daily reports to the TMBC Community Safety Team which detailed the locations they had visited, the interactions they had had with residents or businesses and highlighted any concerns raised by residents/businesses. These reports were then followed up by the TMBC Community Safety Team and relevant information passed to either internal teams (such as Waste services) or agencies such as the police.

Weekly meetings were held with Kingdom to task them to specific areas, raise any concerns with them or to allow for them to feedback any incidents they wished to discuss. Where parish/town councils had contacted us with specific issues, we were able to schedule visits to identified areas of concern.

The table below shows the work of the ASB Team during the six-month period. For the data provided we were reliant on the information provided to us by Kingdom. To the best of our knowledge the information provided was accurate.

The Team provided high visibility patrolling and provided reassurance to the public. They spoke to over 1,000 members of the public, over 350 businesses and 95 groups of young people.

Feedback from residents has been positive and the comments below are examples of what the Team fed back to the TMBC Community Safety Team:

*“Ed lives locally and said nothing antisocial happening here, he is satisfied and enjoys living here, he appreciated us being there and mentioned that this should be the case for other streets around here too”.*

*“We patrolled the recreational ground which had a number of families enjoying themselves. I spoke to a gentleman called Paul who is local, he said he hasn't seen or heard of any incidents, and he is here daily walking his dog. He said it was nice to see us there patrolling”.*

*“The parking lot (at McDonalds) was full of customer's cars, we patrolled the whole area to let everyone know that we are here so that no one gets involved in ASB”.*

*“Since my last report I have not had any problems, the children have been leaving our building alone thankfully. I do notice a difference in behaviour when the officers have been around, thank you for your help with the residents' concerns”.*

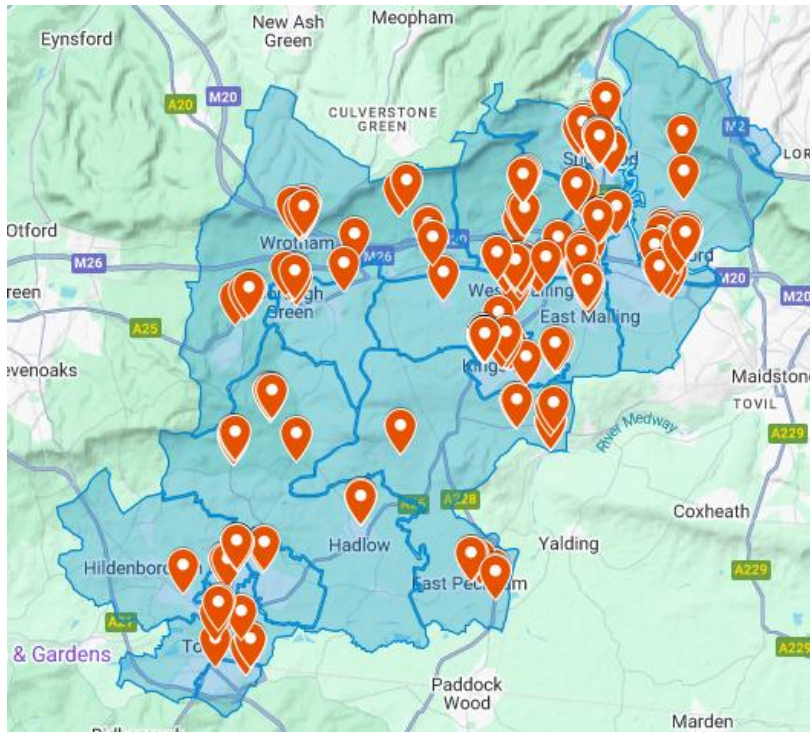

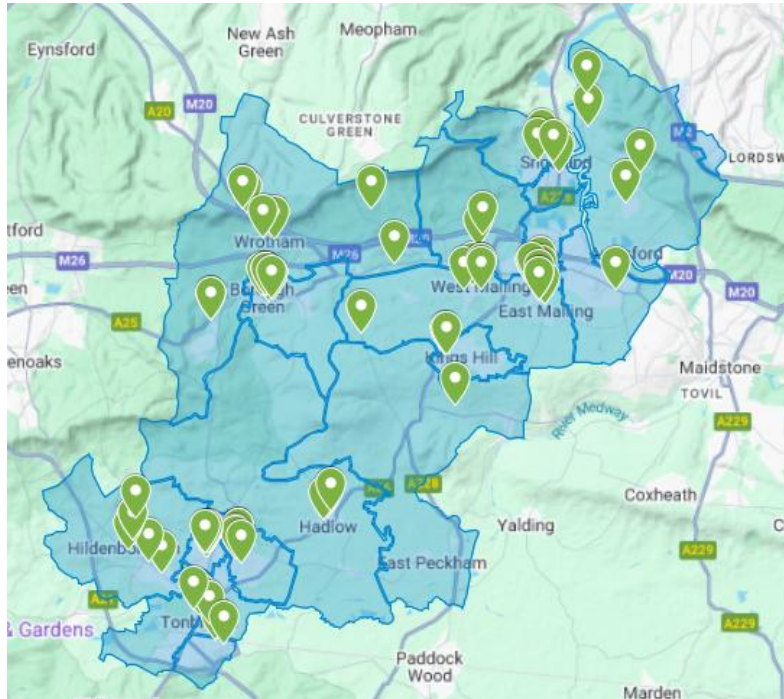
