## 166. Adjournment of the meeting to allow for public participation (subject to the provisions of Standing Order 1(d))

Mr Kahl and Mr Friend, residents of Laurie Grey Avenue, Blue Bell Hill

166.1 - Both referred to the **Upper Bell** and the continued concerns of residents of Blue Bell Hill at the apparent building works going on without planning permission. They also asked Cllr Homewood if he was aware of why the tarmacing and kerbing had been undertaken by KCC which now allowed the Upper Bell owner easy access on to his site to carry out these works.

Cllr Homewood stated he had not been consulted by KCC about the works.

Cllr Balcombe stated he was aware that there are still enforcement issues going through TMBC and that no further planning applications for the site have been received. The local Borough Councillor for the ward Cllr Sullivan is closely monitoring the situation.

Mr Kahl and Mr Friend felt strongly that not enough was being done at any local authority level to prevent the unauthorised development of this site. They have been raising the matter with the Parish Council for over three months and there have still been no positive actions by any party.

Members instructed the Clerk to write to KCC, TMBC and Tracey Crouch MP urgently to seek clarification on all aspects of this site. Cllr Homewood also undertook to raise the apparent co-operation of KCC with the site owner.

### 166.2 – KCC Safe and Sensible Street Lighting Scheme (SSSLS)

Mr Friend reported that Kent Highways have not returned to complete the maintenance/cleaning of street lighting in Laurie Grey Avenue. He continued to query the fact that the turning off of street lights in the area at midnight was not acceptable to residents. Cllr Homewood stated that he now had a direct KCC link for complaints and comments on the SSSLS.

The Clerk referred Members and members of the public to Appendix A of the ESC minutes of 25 February which detailed KCC's consultation process and reasons for the decision to reduce the lighting period of 70,000 of their 120,000 lights. KCC are not prepared to change their policy and criteria for the SSSLS but will consider applications from members of the public for review of individual roads.

Mr Ainsworth, Walsham Road, Walderslade

166.3 – Mr Ainsworth informed Members of his recent communications with KCC re SSSLS which he considers leaves **Walsham Road** in unacceptable darkness after midnight. He has been informed by a KCC Officer that his only method of expressing his view is via his County Councillor (Cllr Homewood). Cllr Homewood stated this was not correct. Although he is happy to consult with Mr Ainsworth, members of the public can use the link referred to above (166.2). Mr Ainsworth invited Cllr Homewood to visit Walsham Road just before midnight to witness the change when the lights go off at midnight. Cllr Homewood agreed to to this.

There being no further public participation, the Chairman thanked residents for their attendance and reopened the meeting.
