Matters Arising

86.1 – Page 1, Item 3.2 – TM/17/03350 – Former Somerfield Depot.

Objection proposed by local members as follows:

The Council objects to this application on the following grounds:-

(1) That the Council does not want to see an increase in the number of dwellings on this site

- (2) That the increased number of dwellings on this site will lead to a further increase in traffic movements (a point accepted by the applicant) along Station Road, Hall Road and the already over capacity A20 at the Hall Road/A20/Quarrywood Industrial estate junction
- (3) That there is no increase in the car parking provision even though there is an increase in dwellings and a likely increase in vehicles wishing to park at this site whether living there or visiting
- (4) That the Council would not wish to see the removal of the affordable housing provision from this application as this is part of a well thought out strategy in respect of the needs for housing in this area. If there is no affordable housing provided as part of the development there must be a financial contribution in lieu of the loss of this type of housing provision. It is also important that any decision made in respect of this should be made before the construction of any further buildings commences.

This was proposed for agreement and forwarding to TMBC by Cllr Wright, seconded Cllr Balcombe. AGREED

89. County Councillor Homewood

89.1 - A20 (Homebase) Flooding – Following a number of flooding incidents over the Christmas and New Year period, Cllr Homewood has pursued an urgent resolution with KCC who have agreed to prioritise the site. Discussions are now on-going with Crown Estates who own the adjacent land regarding installation of a pumping station.

89.2 – **Walderslade Woods Road/Lower Robin Hood Lane** – Cllr Homewood is aware of Borough Councillor Keers campaign to get an interactive speed 30mph sign at this location. To this end Cllr Homewood has funded speed cable installation to gather the required back up information.

89.3 – **Cabinet Member for Highways** – Mike Whiting has replaced Matthew Balfour as KCC Cabinet Member for Highways.

89.4 – **Bus Consultation** – Cllr Ludlow asked about the consultation document on subsidised bus services which had appeared on the KCC website but was then withdrawn. Cllr Homewood responded that this consultation would be reinstated later in the year in preparation for funding reductions required in 2019/20.

90. Borough Councillor Base

90.1 – Cllr Base reminded Members that Borough Councillors cannot campaign on **planning matters** in their areas as this would invalidate their vote as a Member of the TMBC Planning Committee. Seeking local views and voicing concerns as a consultee on planning applications must therefore fall to the Parish Council.

90.2 – Cllr Base detailed the savings required in the 2018/19 and 2019/20 **TMBC Budget**. There are likely to be some substantial changes in services and postponed projects and he will expect to see the Parish Councils asked to take on more responsibilities.
