- 82. Cllr Homewood gave the following reports and responses to questions:
- 82.1 Blue Bell Hill slip road towards Eccles/Aylesford Lighting is again out on this road. Cllr Homewood will pursue with Kent Highways.
- 82.2 Robin Hood Lane/Maidstone Road island has been constantly damaged by HGVs running over it. The verge has now been cut back and kerb realigned.
- 82.3 Gritting and salting programme has been running successfully and at full strength during recent snow and low temperatures.
- 82.4 Cllr Smith reported that HGVs are still entering the village thinking they can gain access to the A229. The 'red sign' advising no entry requires tree clearance. Cllr Homewood will arrange this.
- 82.5 Cllr Walker thanked Cllr Homewood for arranging for the barrier installation at the bottom end of the disused Common Road slip road. It is hoped this will help prevent fly tipping at this location.
- 82.6 Cllr Walker asked Cllr Homewood to chase up the installation of 'halos' around the Hall Road zebra crossing, which have been outstanding for several months. Cllr Homewood will pursue.
