- 62. Cllr Base reported that TMBC's relatively comfortable financial situation over recent years due to its housing stock transfer and the Kings Hill development is likely to be coming to an end. There is an expected 36% cut in funding from central Government and a cost cutting exercise to be carried out which could impact on the financial support given to Parish Councils and this matter was being considered by the TMBC Scrutiny Group. It was expected that 2016/17 would not be affected but there could be issues in future years.
