AGENDA ITEM 9 - To receive the observations of the County Councillor

- 77.1 Cllr Homewood reported on KCC's likely intention to sell the **Blue Bell Hill Picnic Ground** for an expected price of circa. £40,000. A large part of the site is leased to Kent Wildlife Trust and they may be a possible purchaser. KCC have emphasised that interested parties must submit their plans for the future use of the site and these plans may influence the decision of KCC on who to sell to, not necessarily the highest bidder. The site falls within the boundaries of Burham Parish Council with the main entrance off Common Road, BBH, which is in the Aylesford Parish.
- 77.2 Cllr Homewood reported on the **Bull Lane**, **Eccles pedestrian crossing** project. The design is now with Amey being safety audited so things are progressing.
- 77.3 Cllr Homewood has a meeting with KCC Highways at which he will raise the outstanding improvements to the Hall Road, Aylesford zebra crossing and traffic flow at the Quarrywood Retail site/A20/Hall Road junction.

AGENDA ITEM 10 - To receive the observations of the Borough Councillors

- 78.1 Cllrs Hammond and Walker reported they will be holding an open clinic at The Base Camp, British Legion Village on Saturday 13 February 11am.
- 78.2 Cllr Walker reported that the expected decision of the TMBC Scrunity Committee is that due to financial restrictions the TMBC Summer Playscheme will be withdrawn with immediate effect.
- 78.3 Cllr Base reported that there has been a 47% cut in Government funding to TMBC and this could result in cuts of up to 60% in some areas. He confirmed the Playscheme is likely to go and there will be other radical proposals to come.

All Borough Councillors undertook to keep the Parish Council informed as proposals are muted and decisions made.
