AGENDA ITEM 1 - Declarations of Interest additional to those contained in the Registry of Members' Interests

87. - There were no declarations of interest additional to those contained in the Register of Members Interests.

AGENDA ITEM 2 - Apologies for absence

AGENDA ITEM 4 - Adjournment of the meeting to allow for public participation (subject to the limitations of Standing Order 29 d)

90. Mrs Wray, resident of Blue Bell Hill. Mrs Wray raised the problem of HGVs still entering BBH village, presumably being directed by their Sat Navs, attempting to access the A229. They are causing extensive damage to the verges when realising their mistake and trying to turn round. One damaged a tree with Christmas lights which were left dangling and the No Entry sign has been knocked down on a number of occasions. Mrs Wray has contacted KCC to request more signage to indicate that there is no access to the A229 through the village, including a pictorial sign to assist nonenglish reading drivers. She has received no positive response.

Cllr Smith confirmed Mrs Wray's concerns which he has raised with the Parish Council and KCC on a number of previous occasions. The corner of Maidstone Road has been tarmacked to make turning easier but no action has been taken to prevent them entering the village in the first place. Cllr Smith would like to see a signs at the entrance to the village stating "No Access to the A229" and "No HGV access".

The Clerk confirmed that he has previously written to KCC about signage and SatNav updates and has been informed that this "no access" information is added as systems become due for updates. The Clerk asked Mrs Wray to send exact details of recent incidents which he will then take up again with KCC. Mrs Wray agreed to do this.

The Chairman thanked members of the public for their interest and attendance and reopened the meeting.

Matters Arising

99.1 – Page 5, Blue Bell Hill Pond Site

Cllr Smith asked for an update on responsibility for the fencing on this site. Clerk advised that the resident has been informed that the fence does not belong to the Parish Council and therefore it has no responsibility for its maintenance or repair. Noted.

AGENDA ITEM 9 - To receive the observations of the County Councillor

100. Cllr Homewood has given apologies to this meeting and there was no report.

AGENDA ITEM 10 - To receive the observations of the Borough Councillors

101. Borough Councillor Base (Aylesford North and Eccles)

101.1 – Cllr Base reported that the 2017/18 Council Tax demands have been issued to residents together with an explanatory leaflet on the changes this financial year. This includes the change in the funding regime for parished areas whereby previously they have subsidised the non-parished areas of the Borough such as Tonbridge town centre.

101.2 – In view of the report by Mrs Wray earlier in the meeting, Cllr Base undertook to raise the matter of enforcing traffic regulation, including HGVs and speeding, by the police with the Crime Commissioner for Kent at a meeting to be held on 23 March. Matthew Balfour of KCC is also promoting more police enforcement in these areas. Cllr Base added that rural areas in particularly require more pro-active and visible enforcement.

101.3 – Cllr Wright asked that reports of fox poisoning in Walderslade open space areas be advised to the Borough Council. A number of fox carcases have been found and a number of dogs have also suffered poisoning, some fatally. Areas involved appear to be increasing. Cllr Base undertook to pass on this information.

The Clerk also asked Cllr Wright to email him full details of these reports and he will pass them to the local PCSO. Warnings will also be posted on the Council's website.
