- 71. Borough Councillor Sullivan (Walderslade and Blue Bell Hill)
- 71.1 Robin Hood Lane speed concerns Borough Councillor Keers has taken this matter up on behalf of concerned residents. Speed monitoring strips to be installed for analysis and 30mph signs to be reviewed and cleared/cleaned.

Cllr Winnett asked why Kent Highways were prepared to carry out these investigations in RHL when he considered the speeding problem in Fostington Way was much worse. There are no 30 mph speed limit signs on this road.

71.2 – Upper Robin Hood Lane development – This development of 5 dwellings which was refused by TMBC and had its appeal dismissed, has been resubmitted now with a the reptile survey included. The omission of this survey was the only reason the appeal was dismissed so there is every likelihood there is now no case for refusal.

71.3 – Nil Desparandum (Big World Motoring) – There are concerns at the tree felling and land clearance being done on this site without permission including possibly trees with TPOs. TMBC are being assisted in their investigations by the Forestry Commission and a 'Stop' notice has now been placed on the site.

Cllr Smith reported that he believed work continues on the site despite the 'Stop' order. It is not clear exactly what area/type of work the 'Stop' order relates to and the Clerk was asked to make enquiries with TMBC Enforcement.
