- **1.Apologies** from Cllrs Balcombe (personal commitment), Base and Walker (TMBC meeting) were noted and reasons accepted.
- 2. Declarations of Interests There were no declarations additional to those contained in the Register of Members' Interests.
- 3. Presentation by South East Water on Water Resources Management Plan

Mr Dance and Ms Shippey distributed a presentation on the SEW Draft Water Resources Management Plan, copy attached at Appendix A to the bound copy of these minutes. This documents, which is updated every five years, will be going out to public consultation in the early Spring this year. A public exhibition is planned in Aylesford on 20 March.

Mr Dance took members through the document page by page, taking questions as raised. Particular note was made of the proposal for a local project at the Aylesford Newsprint site.

Members thanked Mr Dance and Ms Shippey for attending and for an interesting and informative presentation. They looked forward to the public exhibition in March.

#### A. FOOTWAYS/HIGHWAYS/LIGHTING MATTERS

- 1. General Highway Report No report to this meeting.
- 2. Eccles Highway Matters

## 2.1 - Bull Lane/Pilgrims Way junction

The Clerk reported that a number of questions had been received from the Bull Lane Safety Group relating to 1) the cutting back of vegetation on both sides of the Bull Lane/Pilgrims Way/Rochester Road junction; 2) the 40mph zone at the top of Bull Lane and why this had not been replaced by 30mph; 3) why part of the main road through the villages of Burham and Wouldham had a 20mph zone and not Bull Lane through Eccles.

The Clerk indicated that in respect of the sight lines relating to Bull Lane/Pilgrims Way/Rochester Road junction, the County Council had indicated that they had a responsibility to maintain visibility and would cut back hedges etc to boundary lines 6 times a year. If this was not sufficient they could be asked to do more. It was agreed that the Clerk would monitor the situation and that the Committee would review the matter at each meeting.

In respect of the 40mph speed limit at the top of Bull Lane, the Clerk reported that KCC had informed him that they had decided to retain the speed limit at 40mph. However if the Parish Council wishes to see a reduction in the speed to 30mph they could appoint a Traffic Management Consultant and start the process of change themselves. However as part of this they would need the agreement of the Police to the change and consult with residents and statutory consultees. The Council would also probably need the approval of the Highway Authority, KCC, who did not want to make the change.

The Clerk reported that the Parish Council has asked that a 20mph limit be introduced in Eccles but has been informed by KCC that it did not meet the criteria for a reduced speed limit of 20mph. He indicated that the Parish Council could also use the Traffic Management Consultant approach for this change as well. It was **agreed** that the Clerk investigate the approach of using a Traffic Management Consultant and report back to the Committee on how feasible this option was particularly in respect of the need for the approval by the Highway Authority.

2.2 – New Banner – Clerk has received a request from the Bull Lane Action Group for the Parish Council to fund another banner for the site requesting information regarding accidents and near misses at the junction. This request was deferred to enable local members to have further discussions with the Group.

## 3. Blue Bell Hill Highway Matters

- 3.1 Slow sign on slip road off the A229 towards Aylesford currently situated under the bridge. Clerk has asked that Kent Highways move the sign to the actual slip road before the Lower Warren Road junction to improve safety at this junction as well as the junctions under the bridge. Response awaited. Clerk to pursue.
- 3.2 Lighting repairs still awaited on the slip road which were scheduled for August. KCC have reported they are still awaiting delivery of new columns. Date postponed from December to 21 January but Members reported lights still not working this evening. Clerk to pursue.

#### 4. Aylesford Highway Matters

4.1 - Aylesford Village Square - Awaiting conservation agreement to the proposed revised materials which will then allow the whole scheme to be repriced.

### 4.2 - Aylesford Village/Forstal Road junction

Site meeting held with Kent Highways re proposed improvements to this junction to include safer pedestrian access and improved signage. KH took on board comments from local members but have now reported that the project did not make the approved list for works in 2018/19.

- 4.3 **A20/Homebase Flooding** Awaiting formal notification that pumping station is to be installed on Crown Estates Land (retail site). See Cllr Homewood's report to Council 16 January 2018 89.1. Clerk will also raise this at the meeting to be held with Crown Estates tomorrow (24 January).
- 4.4 **Somerfield Site, Vehicle Cleaning** Awaiting response from TMBC Planning re muddy condition of Hall and Station Roads.

#### 5. Walderslade Highway Matters

- 5.1 Robin Hood Lane Local Members have noted that 'speed/traffic counting' wires have been installed in the Medway section of Robin Hood Lane. Clerk reported that KCC have stated they have not been installed by them. Clerk to enquire with Medway. Clerk
