## 1. Apologies for Absence

Apologies of Absence from Councillors Gledhill (Holiday), Ms Oyewusi (work commitment) and Wright (Personal Commitment), were received, and the reasons for absence agreed.

#### 2. Declarations of Interest

There were no declarations of interest additional to those contained in the Register of Members Interests.

#### 3. Minutes of the Meeting held on 23 July 2019

It was **Agreed** that the Minutes of the meeting held on 23 July 2019 be approved as a correct record and signed.

#### 4. Section 137 Donation Requests

The Clerk reported that he had received a request from the 2374 (Ditton) Air Cadet Squadron for a donation towards the cost of a second Minibus. They currently have a membership of 30 and with only one minibus struggle to take as many of their cadets to camps, military parades as they would like. They are therefore seeking to purchase a second minibus that could take 8 children and their kitbags. They have indicated that they will put a sign on the new bus indicating those that have contributed. It was **Agreed** that a donation of £300 be made to the 2374 (Ditton) Air Cadet Squadron towards the cost of a second Minibus.

#### 5. Hall Grant/Loans

The Clerk reported that there were no requests for any Hall Grants or Loans.

### 6. Section 137 Micro Grant Requests – Eccles Football Club

The Clerk reported that Councillor Gledhill has received a request from the football club to help the Club fund works to clear vegetation both inside and outside the ground. The works have been undertaken and cost £70. Councillor Gledhill has indicated that he is happy to fund the £70 from his micro grant. There is sufficient funding available.

It was **Agreed** that cost of works to clear vegetation undertaken by Eccles Football Club at a cost of £70 be funded from Councillor Gledhill's Micro Grant.
