Cllr Sullivan referred to residents continuing concerns regarding the condition of the former Upper Bell site and adjacent land. TMBC Enforcement orders are progressing but are in the hands of the Appeals Inspector.

Cllr Sullivan expressed his concern at letters patients of the Burham surgery have received stating that there are plans to stop prescription dispensing from the surgery and that in future drugs may be required to be collected from ASDA. This is not at the request of the surgery and appears to be an NHS directive. Cllr Sullivan is investigating further with the assistance of Tracy Crouch MP.

#### 58.2 – Cllr John Balcombe (Aylesford)

Cllr Balcombe reported that work appears to be progressing well in Aylesford High Street (currently shut to through traffic) on drainage and traffic light improvements. Due to be completed by the end of the month.

Cllr Balcombe drew Members' attention to the latest TMBC Community Enhancement Fund which provides grant funding towards small community projects. Full details to be passed to the Parish Office.
