## 69. Adjournment of the meeting to allow for public participation (subject to the provisions of Standing Order 1(d))

Mrs Rillie (resident of Rochester Road, Aylesford)

Mrs Rillie questioned the objections of the Parish Council and TMBC sent to Kent Public Rights of Way regarding the proposal to reinstate bridleways in Aylesford and Eccles (as per ESC 26 August 2014 – Item 6) as they had previously supported the Valley of Vision project

in the area some years ago which included keeping these areas available to horse riders. Mrs Rillie has been advised of the PC objections by the Kent Public Rights of Way Officer dealing with the case. She realised the objections are based on concerns that removal of the motorcycle inhibitors would lead to a return of anti-social behaviour previously experienced but the areas have been free of this for many years and those who originally caused these problems will now have grown up and moved away. Also a police presence when these troubles were experienced was successful in catching the culprits and the seizure of one of the motorbikes involved was an effective deterrent.

Mrs Rillie stated that she believed the 'horse stiles' proposed to replace the motorbike inhibitors would be effective in preventing motorbike access as they do not have a wide enough gap between the sleepers to allow a bike to be lifted over.

Cllr Homewood commented that the area had had a long historical problem before the installation of the inhibitors with raves, fly-tipping and off road bikes. If the Council could be guaranteed that the new barriers were effective he would welcome the opportunity to reopen the bridleways to horse riders. There must also be access for pushchairs and mobility scooters.

Cllr Gledhill stated that the Parish Council supported horse riding around the Parish but not to the detriment of misuse by anti-social behaviour.

The Clerk reported that had received a response from Kent Public Rights of Way commenting on the objections raised by the Parish Council and asking it to reconsider their objection in the light of these comments. He indicated that he would be submitting this response to the next ESC meeting.

Members agreed to consider Mrs Rillie's and KPRofW comments at the next ESC meeting and to agree at that meeting whether they wished to make any amendments to their objections.

Cllr Gledhill thanked Mrs Rillie for her attendance.

There being no other public participation, the meeting was reopened.

#### 73. To receive the report of the County Councillor Homewood

Cllr Homewood reported on KCC matters since his appointment as Chairman of Kent County Council earlier this year. Much effort is being put into 'Transformation' with many services being put out to private enterprise rather than in house in order to make necessary savings.

Cllr Tiller referred to 'unncessary expenditure' being made in education on Educational Specialists being brought into schools. Cllr Homewood noted his comments.

Cllr Mrs Brooks asked whether these savings would affect childrens' services. Cllr Homewood stated that funding for childrens' services had been ring fenced and secured so there should be no cuts in these areas.

Cllr Homewood reported that £40,000,000 of the Icelandic investments has now been repaid, whilst the remaining £10,000,000 was expected back within the next two years. He added that these originals investments had been made by KCC with HM Treasury permissions.

Cllr Gledhill thanked Cllr Homewood for his report.
