150. Adjournment of the meeting to allow for public participation (subject to the provisions of Standing Order 1(d))

Mr Kahl and Mr Friend, residents of Laurie Grey Avenue, Blue Bell Hill

150.1 - Both referred to the **Upper Bell** and asked if Members had any further information on the enforcement matters. The Chairman reported there was no update. Mr Kahl and Mr Friend both reported that KCC appear to have installed a drop kerb and tarmacked the drive into Common Road and wondered how this had been arranged. The Clerk will see if

Borough Councillor Sullivan has any information and/or will contact the Kent Highways Steward.

150.2 - Mr Friend reported that Kent Highways have done some work to their **street lighting in Laurie Grey Avenue** but did not clean all the lights and still need to attend to lights where access is more difficult. This work is even more important now Kent Highways are introducing their 'Safe and Sensible Lighting Policy' meaning that lights are going out at midnight.

150.3 – Mr Friend reported that drainage work in the Blue Bell Hill area has been done including clearance and flushing out.

Mr Ainsworth, Walsham Road, Walderslade

150.4 – Mr Ainsworth expressed his objection to the KH 'Safe and Sensible Lighting Policy' which he considers leaves **Walsham Road** in unacceptable darkness after midnight. He was concerned at the apparent lack of consultation with local residents and lack of advance notice that it was going to take place. At the very least he would like to see some individual lights in Walsham Road selected for all night lighting. Mr Ainsworth stated that he had contacted County Councillor Homewood regarding this. PH had acknowledged his enquiry but he is still awaiting a formal response. Mr Ainsworth will also be taking the matter up with Tracy Crouch MP.

The Chairman stated that the Parish Council will ensure Mr Ainsworth's concerns are passed to all involved parties Clerk
