was discussed together with details of the landscaping proposed. There was also an interesting site visit. It is very early days in the 25 year scheme and work will not really commence until Spring 2014 beginning with the building of a subway to link the two sites which will take approximately 9 months. The next meeting of the Advisory Group is therefore not planned until September 2014.

Kent Highways have agreed there is a need for more gullies in Aylesford High Street to improve drainage. Site meeting awaited.

MUGA for Ferryfield – Cllr Smith asked for progress details. Advised that quotation will be considered at ESC on 24 September. Parish Council will probably have to fund whole project initially as S136 payment will not be made until Bunyards Farm development commences. Actual siting still be agreed.

- 75.3 Page 5, 16. Podkin Meadow Tarmac footpath surfacing work is now showing to be unsatisfactory with weeds growing through it and no edging to prevent soil falling through from adjacent garden.
